General Requirements for all documents:

- Letter and Legal sized documents accepted.
- County will process e-recordings Monday-Friday between the hours of 8:30 am and 4:30 pm MST.
- Images must be submitted at 300dpi.
- Non-Conforming documents will be rejected.
- Cannot currently process Releases of Deed of Trust/Reconveyance.
