General Requirements for all documents:

- A margin of at least 1/2" inch is required at the top of the first page on the sides and bottom and at the top of subsequent pages.
- Letter or Legal sized documents accepted.
- Images must be submitted at 300dpi.
- Recording Hours: M-F, 8:00 to 4:30 PM (County will accept docs at any time).
- Note: UCC's must be filed through the state.
